Background Information

The National Commission on Military, National, and Public Service (NCMNPS) was created by Congress to conduct a review of the military selective service process and to consider methods to increase participation in military, national, and public service among all Americans in order to address national security and other public service needs.

Established on September 19, 2017, The Commission is an independent establishment of the Federal government comprised of eleven members appointed by Republican and Democratic leaders in the Congress and by the President. The Commissioners bring together diverse experiences from service in the military, public office, Congress, and nonprofit organizations.

The Commission issued an interim report on January 23, 2019 and will issue its final report in March 2020. The final report will include policy recommendations and legislative proposals regarding all issues in the Commission's broad mandate. By statute, the Commission will cease operations on September 18, 2020.
